## **INITIAL ARTICLES OF INCORPORATION**

Of

### **PARMA EDUCATIONAL FOUNDATION, INC.**

*(For Domestic Non-Profit Organization)*

#### **THIRD: PURPOSE**

1) Parma Educational Foundation, Inc. (the "Corporation") is organized exclusively for charitable and educational purposes. Specifically, the Corporation is formed for the following purposes:

- a) To accept and expend funds in support of such curricular and extracurricular activities, programs and facilities of the public schools operated by the Board of Education of the Parma City School District as the Board of Trustees of the Corporation may from time to time determine, and to provide financial assistance to such graduates of said schools to assist in their pursuit of post-secondary education as the Board of Trustees of the Corporation may from time to time determine.
- b) To take and hold by bequest, devise, gift, purchase, or lease either absolutely or in trust, for any of its purposes, any property, real or personal, without limitation as to amount or value; to sell, convey and dispose of any such property and to invest and reinvest the principal thereof, and to deal with and expend the income and principal of the Corporation for any of the purposes hereinbefore set forth.
- c) To do all things necessary or appropriate in order to accomplish the foregoing purposes.

The Corporation as part of its charitable purposes may also make distributions to other organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

2) The assets of the Corporation are dedicated to the charitable purpose described in Paragraph 1) above.

3) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to and to make payments and distributions in furtherance of the purposes set forth in Paragraph 1) above. No part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation,

and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Furthermore, notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not permitted to be carried on by a corporation exempt from the federal income tax under Section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code or by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

4) Upon dissolution of the Corporation, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not so distributed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization(s) as said court shall determine, which are organized and operated exclusively for such purposes.
