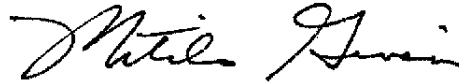
**DIRECTOR'S ACTION BY UNANIMOUS WRITTEN CONSENT**

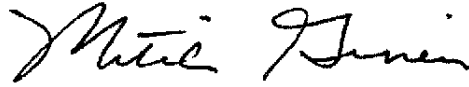
